

## **Green County Traffic Safety Commission Meeting Minutes March 15, 2018**

The Green County Traffic Safety Commission met at 1:00 pm on Thursday, March 15, 2018 at the Green County Highway Commissioner's office located at 2813 6<sup>th</sup> Street, Monroe, Wisconsin.

Call to Order: Chairman Chris Narveson called the meeting to order.

Members present: Mark Rohloff, Sheriff, Ryan Mayer, Wis. DOT; Dan Noble, State Patrol; Chris Narveson, Highway Commissioner; Trace Frost, WisDOT BOTS; Joe Davis Sr., WisDOT BOTS; and Katrina Hecimovic, SWWRPC.

Roll call / sign in: Everyone introduced themselves and signed in.

Review proposed agenda: Agenda was approved as submitted.

Approval of minutes: A motion was made by Mark Rohloff and seconded by Ryan Mayer to approve the minutes from the December 21, 2017 meeting. The motion carried.

Public Comments: None

Old Business: Discussion took place regarding the request for speed limit change in the village of Belleville, the speed limit will be reduced to 35 mph on the East side of town, new signs will be put up.

New Business: Joe Davis was introduced as the Regional Program Manager for Green County.

### Commission Member Reports:

Sheriff Mark Rohloff - Handed out the quarterly accident summary, and reviewed the details of fatal crashes with the committee. He talked about the possibility of adding rumble strips or flashing beacon on the stop signs at CTH T and STH 81. Chris Narveson review the cost of the rumble strip addition and assess the area to see if they can be installed. Ryan Mayer will review the crash data for this intersection. He also state that he has received complains on STH 11/81 at CTH S regarding Semi traffic, there needs to be a wider turn lane on the NE corner of the intersection. Chris is going to talk to the state and see what can be done there and with talk to Grande to see about cost sharing the project.

Chris Narveson – Discussed the request for a speed limit reduction on Main Street in Monticello, if lowering 10 mph or less the Highway Committee can authorize that change.

Trace Frost – Reviewed fatal crashes in which pedestrians were involved statewide. Discussed community maps: Maps are updated automatically once crash reports are completed by law enforcement, this does not include self-reported accidents. There is a tab, which is open to the public, advanced, and analyzed tabs are accessible to the Highway Department and law Enforcement.

Katrina Hecimovic – Is working with Green County on a public transit plan, they are hoping to put together a 5 year plan. There is a public meeting May 15, 2018 at 12:30 at the Monroe Public Library.
